- During the visit the condition of a number of trees were such as to require immediate attention to prevent damage to persons or wall and gravestones in the Church.
- In the light of the advice and the poor condition of the trees the contractor was instructed, on the grounds of safety, to remove the relevant trees with the work being completed on Friday 25th November, 2016, at a cost of £, 450.00(ex VAT).
- **Resolved:** To receive, note and approve the actions taken.

122.15 Drefach. Multi Use Equipment:

- Draft drawings finalised and the contractor asked to confirm the price.
- As the metalwork is being fragmented and galvanised the replacement item would not be available until early in the new year.
- Once the order has been issued the current equipment will be dismantled and safety fencing put in place until the item has been re-assembled.
- **Resolved:** To receive, note and approve the actions taken.

122.16 Drefach. Boundary Hedge Growth No's 39 and 41 Brynglas

As resolved at the last meeting a specialist tree surgeon together with the Clerk visited
the park and examined the position in relation to the possibility of trees within the park
interfering with the satellite reception for the properties in question.

- In summary, the contractor was of the view that the cause of the difficulties is a large tree which is located on what seems to be private property, adjacent to but on higher ground than the properties at Brynglas
- Given the significant distance the properties were from the park and that in terms of aspect they were not facing the park there was nothing which the Community Council could do to assist.
- Cllr Wyn Edwards advised members that he had visited in person those living at the property to discuss their concerns and from which it could be noted that the receiver for no 39 was indeed directly in line with a large tree which was outside of the park.
- **Resolved:** To receive and note the information provided.

123.3 Cefneithin Park. Tree Risk Assessment.

- The Clerk together with Shapewright drainage contractor visited Drefach Park on Wednesday 30th November,2016, to assess drainage requirements two local residents of the Brynglas Estate made themselves known to the Clerk and relayed their concerns that should the trees in the habitat area grow they would prevent parents from being able to view children playing.
- They request that the Council remove the trees on the grounds of safety.
