90.0 Agenda Item 1: Record of those Present/Apologies

90.1 Welcome

• The meeting commenced at 7.00p.m. with the Chair welcoming and thanking members for their attendance.

91.0 Agenda Item 2 Declaration of Interest

- Declarations of a personal but not prejudicial interest were declared by Cllr Darren Price as an elected member of the body seeking to purchase the land and also by Cllr Janice Price as a Governor of Gorslas C, P. School.
- The Clerk advised that a dispensation had been applied by the monitoring officer in relation to allowing members to take part in discussions relating to the matter.
- Cllr Darren Price also declared a personal interest in an application for financial assistance by Cefneithin Rugby Club which was to be considered under agenda item 12 Finance. The interest related to the fact that his son was a member of the club and the group for which funding was being sought.
- **Resolved**: To note and record the declaration of interest.

92.0 Agenda Item 3. Exclusion of Press and Public.

95.0 Agenda Item 6 Parks and General Matters.

95.1 Proposed Sale of Land at Gorslas Park - New Primary School.

- Members were advised that discussions were ongoing within the County Council relating to the terms attached to the sale of the land. Once these had been concluded the County Council would convey their decision to the Community Council immediately.
- The County Council had confirmed that they did not require access to the site for the remainder of the current year.
- The Gorslas Welfare Association have been advised accordingly and that the park would be available for the annual Christmas/ Firework event.

Resolved:

- (ii) That authorisation be given to convene an additional meeting of the Council for the purposes of considering the County Council response to the proposed terms for the disposal of the land should that be required to expedite matters.

95.3 General: Vacancy Cefneithin Ward

- As required a notice had been placed in the public notice boards in each of the three wards giving electors 14 days within which to request an election.
- The County Council have confirmed that as no request were received by the closing date the Community Council may co-opt an individual to fill the position.
- In accordance with Section 116 of the Local Govt (Wales) Measure 2011 a public notice must be published by the Community Council advising of the vacancy.

• Resolved:

95.4 Gorslas Park. Re-Cycling.

- Year 1 at Gorslas C.P, School have visited Gorslas Park expressing disappointment that there are no re-cycling bins within the park and asking that some be provided.
- The request has been acknowledged and the County Council contacted to obtain estimated costs of providing such bins. A cost has been requested for the weekly collection and re-cycling of the waste.
- Additionally, CWM who operate the Nantycaws re-cycling facility offered a tour and talk on the re-cycling work they do for the class. The offer has been forwarded to the school.
- **Resolved:** To receive and note the information provided.

 As part of the locking up of the facilities on Saturday 13th October,2018, Cllr Aled Vaughan Owen had reported to the Clerk that the fixed metal large toilet roll dispenser in the baby change unit had been broken open and damaged.

- The Clerk reported the matter to the Police and a Scene of Crimes Officer attended the scene on Sunday 14th October to examine and collect evidence.
- The contractors cleaned the facility that day and replaced the metal toilet dispenser.
- **Resolved:** To note and receive the information provided.

95.8 Gorslas Public Conveniences. Anti- Social Behaviour.

- An incident of verbal abuse and threats against a volunteer locking the facility had occurred on Thursday 25th October,2018. The Police were advised of the incident.
- Understandably the volunteer was not in a position to continue to lock the facilities.
- Accordingly, a revised rota of volunteers has been arranged and members advised
 that due to the nature of some of the verbal abuse that there should be two persons
 present at all times as a safeguarding measure.
- Members were concerned to learn of the incidents. They reviewed the information available to them and considered options for reducing the risks in future.

Resolved:

- (i) To close the facilities early i.e. during daylight hours.
- (ii) Persons locking up to be advised to carry a mobile phone on their person and to notify a third party /family member of their expected time of return and what to do if they have not returned at the prescribed time.
- (iii) Volunteers be advised that whenever possible two persons be present when undertaking the duties.
- (iv) That all such incidents be reported to the Police.
- (v) The incidents be reported at PACT meetings together with requests for the patrols in the park and seek advice on options for reducing such incidents.
- (vi) The County Council Health and Safety Trainer be requested to attend a future meeting of the Community Council to raise awareness of risks and discuss options for addressing those risks.
- (vii) To continue to monitor the position and examine further the options for reducing risks including CCTV /bodycam options and automatic door closing.
- (viii) That the Clerk contact the members currently undertaking the duties to ascertain if they are prepared to continue to serve in that role.

95.9 Cefneithin Park- Hall Lease.

- The Clerk advised that correspondence had been entered into with the County Council in relation to terminating the agreement to prepare the lease.
- The County Council indicated that they were confident the matter could be completed now be completed quickly.

Resolved

- (i) That a reasonable extension of time be granted.
- (ii) That it be confirmed that the period of the lease be 15 years with the annual payment due being £50.

95.10 Cefneithin Park Gates.

- Estimated costs for replacement gates for the entrance were provided as well as for the refurbishing of the current gates.
- **Resolved:** Agreed to refurbish the gates and include in future maintenance works.

- (iii) The Clerk request, and forward to the working group, details from One Voice Wales of sample Social Media policies and information relating to Authorities who had won awards or recognition for the innovative use of social media.

96.1 Drefach. Parking concerns Ysgol Y Gwendraeth site.

- Concerns had been expressed in relation to parking issues and signage at Uwch Gwendraeth and Henffordd arising out of the use of parking issues on the site of the previous Ysgol Y Gwendraeth.
- It was advised that: -
 - (i) the parking layout at the site had been reviewed by the County Council with it being found that a herringbone system being the best option.
 - (ii) A travel plan for major events at the site had been put in place with a person supervising the parking arrangements.
 - (iii) The signage referred to had not been put in place by the County Council.
 - (iv) Discussions and agreements had been reached between the County Council and Heywood homes in relation to the placing of double yellow lines at the relevant points to help address the issue.
 - (v) It was hoped that work to allow the road to be adopted by the County Council will have been completed by the end of December.
