109.1 Draft Strategic Document.

- The Council then re-convened and considered the feedback from each ward group. In summary the review was welcomed by all wards and agreement that the option for ward members to meet and discuss local matters prior to the main Council meeting being the preferred option.

109.3 Cefneithin Park: Excess Water Concerns.

- Following consultation with Sub-Committee members work to improve the effectiveness of the drainage system in the wooded area of the park had been undertaken.
- The works were checked, following a subsequent period of heavy rain, and found to be working. Certain elements of the work remained for discussion with the contractor.
- It was noted during the visit that a ditch on the Heol Yr Ysgol side of the park was blocked and discharging water across the footpath.
- The Clerk also advised that the County Council Flood Defence Team had been in contact to enquire about the incident. The County Council had received a formal complaint from a householder on the 18th December,2020. The Officer was advised of the actions taken and was content to close the file.

109.4 Gorslas Park. Alleged Damage to Tree.

- A complaint had been received on the 18th December,2020, that the root system of a tree had been damaged as part of emergency drainage work at the park.
- The concern was that the damage to the tree presented a risk to public safety, given its proximity to a footpath, and would lead to the possible demise of the tree.
- A visual inspection was undertaken by the Clerk and contractor on the 18th December,2020, with no immediate danger identifiable.
- Following discussions with the Chair, with safety being the over-riding priority, the services of a specialist Arboriculturist was engaged.
- The Arboriculturist visited site on the 24th December with an initial appraisal indicating that there was no identifiable danger to the public. Further details and recommendations to be provided.
- **Resolved:** To receive, note and approve the actions taken and that any remedial action to safeguard, or replace the tree be authorised following consultation with the Sub Committee Members.
